Learners always access the latest version of ThoughtSpot University content, including video walkthroughs, live exercises, reviews, and quizzes.




No additional logins or site access required

How ThoughtSpot University Content Syndication works

- ThoughtSpot exports an xAPI or CMi5 zip file for each course to be syndicated and shares it with the customer.

 The zip files contain simple XML files that establish the connection between your LMS and ThoughtSpot University.
- Your LMS admin, in turn, creates a course or lesson inyour LMS and imports the xAPI or CMi5 file.
- Your LMS admin then assigns the course to your users.




Content syndication process

The course is then available for assigned users within your LMS, with no need for ThoughtSpot University credentials or additional work for the LMS admin.

Usage and completion statistics are available in your LMS, just like any other course in your library.

ThoughtSpot University Content Syndication is a subscription service, therefore if a customer chooses not to renew their subscription, ThoughtSpot University Content Syndication is terminated and the content will no longer be accessible to Customer or Customer's end users, as of the date of expiration or termination.

In order to use these Consulting Services, Customer must have the applicable license or access rights to a LMS. Customer is responsible for the payment of any fees for the use of their own LMS in connection with these Consulting Services.
